


## Assessing the interconnectedness of ecosystems, water and food Prof. Nicola Fohrer, Global Water Partnership, the German Hydrological Society, Germany

Dr. Nicola Fohrer is professor of hydrology and water resources management at Kiel University since 2003. Her working focus is ecohydrology, water quality and water management in rural areas. She works since many years in China, India and Russia in the context of IWRM. She is vice-president of the German Hydrological Society (DHG) and area coordinator for water at the Indo-German Centre for Sustainability at IIT Madras. She serves as member and spokesperson in the DFG review board for water science, in the Leibniz senate commission for evaluation, in the Global Water Partnership as member of the technical commission (TEC)

The Treaty offers unique opportunities for the melding of western science and traditional knowledge and governance in a post treaty environment where water and the rights Nisga'a People enjoy, are key to their planning, and path forward in the global environment

#### **Demonstrating operational linkages with a wetland buyback scheme Dr. Caroline A. Sullivan,** Southern Cross University, Australia

Professor Caroline Sullivan is an ecological and environmental economist specialising in water management and policy, climate adaptation and valuation of ecosystem services.
